AN ORDINANCE OF THE MCKINLEYVILLE COMMUNITY SERVICES DISTRICT DEDICATING FUNDING FOR REPAYMENT OF THE STATE REVOLVING FUND SEWER CAPACITY EXPANSION PROJECT PHASE 2 LOAN AND AMENDING THE DISTRICT'S RULES AND REGULATIONS TO REVISE THE EXISTING WASTEWATER CAPITAL RESERVE FUND

- WHEREAS, The Board wishes to improve the District's current wastewater treatment disposal capability by constructing Phase 2 of the Sewer Capacity Expansion Project (hereinafter called Project);
- WHEREAS, The District's consulting engineer has prepared the final design plans and specifications for the Project and the Board has selected Contri Construction for construction of the Project at a cost of \$349,668;
- WHEREAS, The District has applied for a loan totaling \$440,000 to cover the construction cost of the Project including engineering and administrative costs;
- WHEREAS, The State of California has agreed to fund up to \$436,673 towards the construction cost of upgrading the wastewater treatment facility (Project) with a low interest loan subject to specific conditions;
- WHEREAS, The Board on July 13, 1995 adopted Ordinance 56 creating a Wastewater Capital Recovery Fund for Phase 1 of the Sewer Capacity Expansion Project and on August 16, 1995 adopted Ordinance 57 dedicating sewer revenues to repayment of the annual debt service on phase 1 of the Sewer Capacity Expansion Project.
- WHEREAS, a condition of the State loan approval is for the District to adopt an ordinance dedicating a source of revenue toward repayment of this new loan; and
- WHEREAS, a condition of loan approval is for the District to adopt an ordinance revising the existing Wastewater Capital Reserve Fund (WCRF) to dedicate additional funding for the expansion, major repair or replacement of the new wastewater treatment works. Specifically, the State requires that the District deposit additional funds to build up the WCRF at a minimum rate of .5% of the Loan amount each year for a period of ten years or for the purposes of this loan \$2,200 per year;

NOW, THEREFORE, THE BOARD OF DIRECTORS OF THE MCKINLEYVILLE COMMUNITY SERVICES DISTRICT DOES HEREBY ORDAIN AS FOLLOWS:

Section 1. Regulation 31 of the MCSD Rules and Regulations is amended to read:

"REGULATION 31 -- WASTEWATER CAPITAL RESERVE FUND

Rule 31.01. WASTEWATER CAPITAL RESERVE FUND -- The District shall maintain a Wastewater Capital Reserve Fund (WCRF) in the Sewer Department dedicated solely to pay for future expansion, major repair and replacement of the disposal works at the Fisher Irrigation Site and treatment works at the MCSD Wastewater Treatment Facility.

In FY97-98, the WCRF shall be budgeted at \$13,053 relative to the FY1995-96 contibution (\$4,100); the interest earned during FY1995-96 (\$246); the FY1996-97 contribution (\$4,100); the interest earned during FY1996-97 (\$507); and the FY97-98 contribution (\$4,100).

Each year in the period FY1998-99 through FY2004-05, MCSD shall deposit an additional \$6,300 to the balance (\$4,100 for phase 1 and \$2,200 for phase 2) into the WCRF. Additionally, the Board shall annually apportion the interest earned on the balance in the WCRF to the Fund.

Each year in the period FY2005-06 through FY2007-08, MCSD shall deposit an additional \$2,200 to the balance into the WCRF. Additionally, the Board shall annually apportion the interest earned on the balance in the WCRF to the Fund.

The District shall annually reconcile the balance in the fund and submit a report to the State Water Resources Control Board every five years (Ie. FY2000-2001; FY2005-2006; FY2010-2011; and FY2015-2016) for the term of the phase 1 and phase 2 Project loans. At the end of the phase 1 loan term, the District Board may reallocate any phase 1 funds in the Fund to any sewer department purpose. Starting in FY2016-17, the District shall annually reconcile the balance in the fund and submit a report to the State Water Resources Control Board in FY2020-2021 for the term of the phase 2 Project Loan. At the end of the phase 2 loan term, the District Board may reallocate any phase 2 funds in the Fund to any sewer department purpose.

Rule 31.02. WITHDRAWAL OF WCRF MONIES. The Board may use money from the WCRF prior to the end of the loan term to pay for the cost of planning, design and construction of capital improvements to the wastewater treatment works subject to adoption of an ordinance committing the District to repayment of any amounts expended from the WCRF at a minimum annual rate of ten (10) percent of the expended amount in addition to the payment described above in Rule 31.01."

Section 2. THE DISTRICT HEREBY DEDICATES AN ANNUAL DISBURSEMENT OF SEWER DEPARTMENT USER FEES TO REPAYMENT OF ANY AND ALL STATE REVOLVING LOANS ON PROJECT C-06-4259-110/120 (Project) UNTIL SUCH LOANS ARE FULLY DISCHARGED UNLESS MODIFICATION OR CHANGE OF SUCH DEDICATION IS APPROVED IN WRITING BY THE STATE WATER RESOURCES CONTROL BOARD.
