ORDINANCE 58

- AN ORDINANCE OF THE MCKINLEYVILLE COMMUNITY SERVICES DISTRICT RESCINDING ORDINANCE 54 AND 55 AND REAUTHORIZING STAFF'S AUTHORITY TO ISSUE SEWER INSPECTION PERMITS
- WHEREAS, The Board has executed a contract with Sequoia Construction for upgrading the Wastewater Treatment Facility's capacity to 1.18 mgd equivalent dry weather flow and Sequuia Construction is obligated to complete this work by February 1, 1996;
- WHEREAS, The Board has adopted a resolution of necessity to acquire the Lourenco Property at 1414 Fisher Road to augment MCSD's disposal capacity;
- WHEREAS, The State of California Regional Water Quality Control Board has reviewed MCSD's wastewater reclamation plan and has agreed that MCSD should be able to comply with all conditions of NPDES Order 94-116;
- WHEREAS, The District's Permitted Discharge Capacity will be 1.18 mgd when all requirements of Order 94-116 are implemented; and
- WHEREAS, The projected dry weather flow of all current customers and those customers with valid permits is projected to total less than 800,000 mgd when those applicants become new customers; and
- WHEREAS, The Board wishes to minimize the adverse economic, social and personal impacts of a moratorium on additional sewer inspection permits.
- NOW, THEREFORE, THE BOARD OF DIRECTORS OF THE MCKINLEYVILLE COMMUNITY SERVICES DISTRICT DOES HEREBY ORDAIN AS FOLLOWS:
- **Section 1.** Ordinance 54 adopted on May 25, 1995 is hereby rescinded.
- **Section 2.** Ordinance 55 adopted on June 7, 1995 is hereby rescinded.
- **Section 3.** Staff is hereby reauthorized to process applications for sewer inspection permits pursuant to the provisions of Article III of the MCSD Rules and Regulations.
- **Section 4.** Staff is hereby directed to notify the Humboldt County Building Department that the District has resumed processing of sewer inspection permit applications.
