ORDINANCE NO. 22

AN ORDINANCE MODIFYING AND AMENDING ORDINANCE NO. 16 REGARDING LATERAL CONNECTION CHARGES

BE IT ORDAINED by the Board of Directors of the McKinleyville Community Services District, Humboldt County, California, as follows:

Ordinance No. 16 Article VI Section 6.01 and Section 6.02 is hereby modified and amended to read as follows:

Section 6.01. Permit Required. In accordance with Article IV of this Ordinance, no person shall construct, extend or connect to any community sewer without first obtaining a written permit from the District and paying all fees and furnishing bonds as required therein. The provisions of this Section requiring permits shall not be construed to apply to contractors constructing sewers and appurtenances under contracts awarded and entered into by the District.

Section 6.02. Plans, Profiles and Specifications. The application for a permit for community sewer construction shall be accompanied by complete plans, profiles and specifications, complying with all applicable ordinances, rules and regulations of District prepared by a Registered Civil Engineer showing all details of the proposed work based on an accurate survey of the ground. The Application, together with the plans, profiles and specifications, shall be examined by the Manager who shall approve them as filed or require them to be modified as he deems necessary for proper installation. After examination by the Manager, a permit shall be issued predicated upon the payment of all fees and furnishing bonds as required by the District. The permit shall perscribe such terms and conditions as the Manager finds necessary in the public interest.
