

ORDINANCE NO. 1
AN ORDINANCE FIXING TIME AND PLACE FOR THE REGULAR
MEETINGS OF THE BOARD OF DIRECTORS OF THE MCKINLEYVILLE
COMMUNITY SERVICES DISTRICT, AND PROVIDING THE MANNER
IN WHICH SPECIAL MEETINGS OF SUCH BOARD MAY BE CALLED,
DESIGNATING AN OFFICIAL MAILING ADDRESS, AND ESTABLISH-
ING THE ORDER OF BUSINESS

BE IT ORDAINED by the Board of Directors of the McKinleyville
Community Services District as follows:

1. The regular meetings of the Board of Directors of the
McKinleyville Community Services District shall hereafter be held
on the first and third Thursdays of each and every calendar month
at the hour of 7:30 o'clock P.M.

2. Special meetings of the Board of Directors shall be held
upon call of the President of said Board, or of two (2) members
thereof, by written notice to be given to each member not less
than twenty-four (24) hours before the time fixed for the
proposed meeting. In the event of any member not being present
at his office or residence when service is attempted, such
service may be made by leaving such notice in the hands of any
occupant of either his office or residence, and if no occupant
be there present at such time, then by posting same at or near
the door of either such office or residence. Such notice shall
specify the time and place and in general terms the purpose
for which the meeting is called. The attendance at such meeting
by any member shall be deemed a sufficient compliance and waiver
of the provisions herein for notice to him.

3. All meetings of the Board of Directors shall be held at
the office of the District, unless they shall adjourn to or fix
another place of meeting in a notice to be given thereof, or
unless prevented by flood, fire or other disaster. Said office
is hereby fixed and established at and in Room 601, McKinleyville
High School, 1300 Murray Road, McKinleyville, California.


4. In the event that any day fixed for a meeting of this

such day shall be held on the next day which may not be a holiday,
at the same hour specified for the meeting to be held.

5. The order of business at the regular meetings of said Board of Directors shall be as follows:


