RE: AMENDMENT TO ORDINANCE # 3

Dear Jim:

Subsequent to adopting the subject Ordinance we installed one 8" meter in the District. This was for the County airport. As you will note (page 30, article 17, paragraph 270) the rate schedule goes only to a 6" meter size. Without going through the formality of amendment, we have been charging them a \$125. per month minimum. Since it appears the U. S. Coast Guard Air Station will also require an 8" meter I think we should amend the Ordinance. The amendment should read 8" meter - \$125.00 after 6" meter - \$100.00.

Please furnish the necessary documents and instructions to effect same. If there are any publication or waiting periods involved I would like to proceed promptly.


Enclosed is the Amendment you requested in your letter of November 6, 1975.


