
ORDINANCE NO. 9

AN ORDINANCE AMENDING ORDINANCE
NO. 4, FIXING THE TIME AND PLACE
FOR REGULAR MEETINGS OF THE BOARD
OF DIRECTORS OF THE MCKINLEYVILLE
COMMUNITY SERVICES DISTRICT.

BE IT ORDAINED by the Board of Directors of the McKinleyville Community Services District that ORDINANCE NO. 4 is hereby amended to read as follows:


1) All meetings of the Board of Directors shall be held at the office of the District unless they shall adjourn to or fix another place of meeting and a notice to be given thereof, or unless prevented by flood, fire or other disaster. Said office is hereby fixed and established at 1656 Sutter Road, McKinleyville, California.

2) This ordinance shall take effect immediately upon passage, and shall be posted by the Secretary at three (3) public places in the District.
