ORDINANCE NO. 13

ORDINANCE FIXING AMOUNT OF REVENUE
TO BE RAISED FROM PROPERTY TAXES

BE IT ORDAINED BY THE BOARD OF DIRECTORS OF THE MCKINLEYVILLE COMMUNITY SERVICES DISTRICT as follows:

SECTION 1. The purposes for which the McKinleyville Community Services District must levy a tax are:

- (a) To provide the funds necessary for repayment of Promissory Notes and Administrative costs with respect to the McKinleyville Sewer Project now in progress;
- (b) To support the general operating costs of the District.

SECTION 2. The amount of money necessary to be raised by the McKinleyville Community Services District by taxation is \$157,868.00.

SECTION 3. The rate of taxes to be levied sufficient to raise the amount of revenue from property taxes as set forth in SECTION 2 of this Ordinance is fixed at 74.844¢ upon each \$100.00 of assessed valuation of all taxable property within the McKinleyville Community Services District.


SECTION 4. This Ordinance shall take effect thirty (30) days from and after its final passage.

PASSED AND ADOPTED by the Board of Directors of the McKinleyville Community Services District on the 9th. day of August, 1977, by the following polled vote:


