
AN ORDINANCE OF THE MCKINLEYVILLE COMMUNITY SERVICES DISTRICT amending portion of Ordinance No. 3.

PASSED AND ADOPTED by the Board of Directors of the McKinleyville Community Services District on the 18th day of August, 1977, by the following polled vote:


