

ORDINANCE NO. 25

AN ORDINANCE AMENDING ORDINANCE NO. 3  
ESTABLISHING RATES, RULES AND REGULATIONS  
FOR WATER SERVICE

BE IT ORDAINED by the Board of Directors of the  
McKinleyville Community Services District, Humboldt County,  
California, as follows:

Ordinance No. 3, Article 6, is hereby amended to include a  
new section as follows:

Section 101.1 District Share in Cost. In the event the  
applicant is required to pay for the construction of a main  
extension across others property frontage where the property is  
already served by the District, the District may share in the  
cost of construction for that portion of the main extension,  
provided it is not a part of the applicants frontage. The  
District will share in the cost of construction only where it  
is the Managers opinion the applicant can not reasonably expect  
a refund as provided in Section 102 of this Ordinance.

The maximum District contribution toward construction  
costs will be fifty per-cent (50%) of the total construction  
cost or One Thousand Two Hundred and Fifty Dollars (\$1,250.00),  
whichever is less.

The District will determine the fair and reasonable  
value for construction of said facilities.

The District will pay its share of construction costs  
when all facilities are completed in accordance with the District  
Standard Specifications and acceptance by the District.


The District will not be a party of any agreement, either  
verbal or written, by or between the applicant and their contractor.

The provisions of this section do not apply to Article 7  
of this Ordinance.

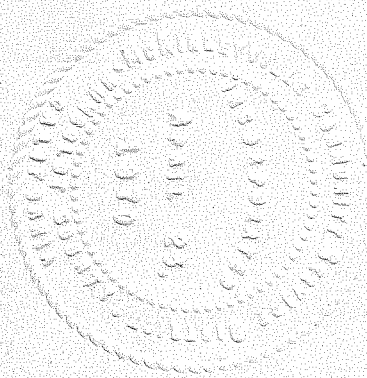
I, Wilmot F. Cooke, Secretary of the Board of Directors of McKinleyville Community Services District, do hereby certify as follows:
