

## ORDINANCE 46

**AN ORDINANCE OF THE MCKINLEYVILLE COMMUNITY SERVICES DISTRICT  
AMENDING THE DISTRICT'S RULES AND REGULATIONS TO ESTABLISH  
RULES FOR PIERSON PARK**

THE BOARD OF DIRECTORS OF THE MCKINLEYVILLE COMMUNITY SERVICES DISTRICT DOES HEREBY ORDAIN AS FOLLOWS:

Section 1. Regulation 45. Operation of Pierson Park is added to read:

**REGULATION 45 - OPERATION OF PIERSON PARK**

Rule 45.01. GROUP BARBECUE COMPLEX. Groups or organizations desiring to use any portion of the complex to the exclusion of others may do so by permit only. The District may issue permits for evening events but not for overnight camping at the shelter.

Rule 45.02. AMPHITHEATER. Groups or organizations desiring to use the amphitheater to the exclusion of others or for the presentation of performances may do so by permit only. A separate permit will be required for the use of a sound amplification system.

Rule 45.03. HORSESHOE PITS. Individuals may use the horseshoe pits on a first come basis. Groups desiring to use the horseshoe pits to the exclusion of others may do so by permit only. Individuals and groups may check out horseshoes from the MCSD office by leaving a \$20 refundable deposit.

Rule 45.04. WESTERLY PICNIC TABLES/BARBECUES. Groups and individuals may use the picnic tables and barbecues located along the western park perimeter on a first come basis.

Rule 45.05. VOLLEYBALL. Individuals may check out volleyball equipment from the MCSD office by leaving a \$20 refundable deposit.

Rule 45.06. OVERNIGHT USE PROHIBITED. No individual shall camp or otherwise loiter on the grounds, in public buildings or in the parking lots between 10 P.M. and Sunrise from Sunday through Thursday or between 11 P.M. and sunrise on Friday and Saturday. No individual shall erect a tent or other camping shelter on the grounds.

Rule 45.07. FIRES. Fires will be allowed only in those areas equipped with permanent fireplaces/barbecues and in portable barbecues designed for the containment of fire.

Rule 45.08. PETS. Pets in the Group Barbecue Complex, Amphitheater, playground and westerly picnic area must be on a leash. Pet owners will be responsible for removal of pet excrement from the park.

Rule 45.09. Bikes/Vehicles. No bikes or vehicles other than MCSD service vehicles shall be operated off of paved or concrete surfaces. Vehicle operators shall operate their vehicles in a safe manner at all times.

Rule 45.10. HORSES. Horses shall be restricted to the hitching post area.


Section 2. This ordinance when effective shall be added to the Rules and Regulations of the District as a codified ordinance of the Board of Directors of the McKinleyville Community Services District.

On the Motion of Director SHEPHERD and seconded by Director HARLING, the foregoing ordinance is duly adopted on second reading this 14TH day of NOVEMBER 1991 by the following vote:


