I, the undersigned, acknowledge the following policies regarding payments and refunds for the Kids' Club After School Program: (Please initial each one)

_____ I understand that **all fees are due on the 1st of the month**. If payment is *not received by McKinleyville Parks & Recreation by the 5th of the month* a 10% late fee will be assessed. If payment is not received by the 10th of the month another 10% late fee will be assessed. If payment is not received by the 15th of the month my child(ren) will be dropped from the Kids' Club Program, and will not be allowed to attend again until all fees due are paid.

_____ I understand that if my child(ren) is/are dropped from the Kids' Club Program, their spot may be given to a waitlisted participant, and reinstatement may not be available once all fees owed are paid.

_____ I understand that if I need to change or cancel my child(ren)'s registration, **I must give a minimum of 5 business days for the change or cancellation to go into effect**. Changes in regard to adding days are subject to availability. This program does fill up and the day or days you wish to add may not be available at the time of your request.

_____ I understand that if I *change my child's registration status more than 4 times during the school year* (i.e. change # of days; drop from program and reinstate later; etc.) an Administrative Service fee of \$10 per change will be applied to your bill.

_____ I understand that I will **NOT** *be refunded for days missed due to illness, vacation or disciplinary suspension*.

_____ I understand that Kids' Club ends at 5:30 and that I will be charged \$5.00 for every 15 minutes that I am late to pick up my child(ren).
